Welcome! This application is your first step in joining the only pen pal web site devoted exclusively to gay men and transgender behind bars in the United States. We have been on the Internet since 2004 and have served thousands seeking compassion, friendship or even loving relationships.

Our rate structure is one of the least expensive and most liberal. Regular listings are \$10.00 and are grouped by the state in which a person is housed. For instance, if there are 100 inmates from Texas they are all listed together under Texas on the same web page. Those listings include one photograph and the information you will be asked to provide on your application at left. Our \$25.00 premiere memberships each get their own web page. You may submit up to 4 photographs and 2 original poems and 2 art works small enough to return in a No. 10 business envelope.

Both types of memberships are valid for one calendar year and you may change your photographs, commentary and address within a reasonable number of times during the year. Memberships can also be extended beyond a year at no additional charge. It works this way, let's say your listing is published on January 1 making the expiration date January 31 of the following year. During that year your address changes and we change it on March 1, then your expiration date moves from January 31 to March 31. The same would happen if you change your commentary or photographs. Each time you communicate with us and wish to have a reply you **MUST ENCLOSE A PRE-ADDRESSED AND PRESTAMPED** envelope. This is required to keep the costs of memberships as low as is possible.

GPUSA's long-standing policy is that you receive 1 print-out of your listing at **no charge** and the printout is sent to you when your listing is first published on GPUSA. We do not provide **free** additional printouts because of the additional cost that would involve. We have amended that policy to provide additional printouts at \$3.00 for each printout requested. The \$3.00 fee **MUST ACCOMPANY THE PRINTOUT REQUEST** along with a stamped and addressed envelope. **NO EXCEPTIONS.**

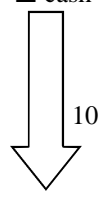
